All forms must be completed and returned to the HBA of F-M office no later than Monday, July 10 to qualify for the early registration discount. The regular registration deadline is Monday, July 24. Each entry must be complete or it will not be accepted.

We will again be using magazine publisher ParadeTix/Utah Media Group, so it is important to follow the deadlines to ensure the magazine is printed and delivered on time. We will also still have our mobile app and event-dedicated website for consumers. Free tickets for the Fall Parade and Tour will be available through the app and website which can be scanned when consumers tour your home. This helps the HBA track demographic information on those visiting homes on the Tour and when.

New this year: Submit your entry information online!

If you would like to submit your entry information online, you must complete the entry application to receive login credentials. Then you can enter home details online. Please turn in the event contract to the HBA no less than 48 hours in advance of the entry information deadline to ensure receipt of your login credentials. Additionally, if you receive login credentials to submit your entry information, those same credentials can be used to view consumer tracking in real time during the event. If you would like to learn more about what information is provided, or how to use the Check-In App, please contact me.

Enclosed in this packet is the entry application, homeowner's participation agreement, a timeline of important dates and a shoe-cover order form.

Important items to note:

- Incomplete entries will not be accepted.
- Construction on the entry must have started after Jan. 1, 2015, and must showcase a change in the shape, style, form or function of a residence.
- All entries must be complete by Sept. 22.

A complete Entry is one in which all final inspections are completed and signed off.

- All homes must be open to the public and two Applicant company representatives must be present during all Tour hours. Consider asking vendors that worked on the project to assist with staffing the home.
- Sign and flag pick-up: 8 a.m. 4 p.m. Thursday, Sept. 21, at the HBA office.
 - All signs and flags must be returned to the HBA of F-M by Friday, Sept. 29 or the Applicant will not be refunded the sign/flag deposit. Flags must be returned even if they are tattered or worn. Official Remodeled Home Tour signs and flags may only be used at designated Tour addresses during event dates.
- A magazine proof will be emailed to each Tour entrant before publication to note any final corrections. Please note that you may not change the address of an entry.

Remodeled Home Tour 2017

Applicant agrees to abide by and is responsible for ensuring compliance with the following Tour Rules and Regulations ("Rules and Regulations"):

- 1. The Entry shall be constructed by the Applicant or Contractor. The Applicant or Contractor must be licensed and in good standing at the time of construction and the Entry shall be constructed in accordance with all applicable government and private laws, regulations and rules including, without limitation, to the International Building Code (IBC) or the International Residential Code (IRC), excluding Appendix E, as adopted by the local jurisdiction in which the Entry is located; fire codes and Building and Use Restrictions. Building permits issued for an Entry must have been issued for the Applicant or Contractor purporting to have constructed the Entry.
- 2. All Entries must be complete by September 22, 2017. A complete Entry is one in which all final inspections have been completed and signed off. No refund will be made for an incomplete Entry after July 24, 2017. All homes must be open to the public and two Applicant company representatives must be present during all Tour hours.
- 3. Applicant must ensure the Entry is safe for Tour participants and the general public. At a minimum and in addition to other requirements in the Rules and Regulations, Applicant must prevent access to areas of the Entry or property where the Entry is located that are not being shown and which may be unsafe or hazardous; properly store all unsafe or hazardous materials; turn off all wiring and outlets accessible to the public at the panel box or install such wiring and outlets properly to eliminate shock hazards; and shall not permit the consumption of alcoholic beverages in an Entry during the Tour. Safety rails on open sides of stairways, landings, porches and other similar areas must be installed.
- 4. In the event that weather prevents Applicant from completing concrete for a sufficient walkway to the Entry, a modified walkway will be accepted, but must meet the following standards: solid, continuous, non-slip walkway surface at least six feet in width that is securely attached to the underlying frame, no more than one foot above ground. Options would include rough plywood that won't get slippery when wet, or a surface that could be covered with an outdoor poly, carpet material.
- 5. Construction on the Entry must have started after January 1, 2015, and must be complete by September 22, 2017. The Entry must showcase a change in the shape, style, form or function of a residence, and must not have been in a prior Tour.
- 6. The Early Registration Entry Fee (due July 10) is \$600 for members and \$1,200 for non-members for the first Entry, plus a \$255 sign and flag deposit (\$855/\$1,455 total). The Early Registration Fee for each additional entry is \$500 for members and \$1,000 for non-members, plus the \$255 sign and flag deposit (\$755/\$1,255 total). The Regular Registration Entry Fee (due July 24) is \$675 for members and \$1,350 for non-members for the first Entry, plus a \$255 sign and flag deposit (\$930/\$1,605 total). The Regular Registration Fee for each additional entry is \$575 for members and \$1,150 for non-members, plus the \$255 sign and flag deposit (\$830/\$1,405 total). Each Entry will receive a half-page "Profile" page in the HBA of F-M's Parade magazine as part of the Entry fee. For more advertising options, contact ParadeTix/Utah Media Group at (801) 204-6377.
- 7. Each Entry must use flags and signs provided by the HBA of F-M only on designated Tour addresses during the Tour dates. Each Applicant must pay a sign and flag deposit for each Entry as described above. HBA of F-M will return the deposit upon receipt of all signs and flags. Applicant will return all signs and flags, damaged or not, to the HBA of F-M office by September 29, 2017. No refunds will be made for items returned after that date. The Applicant is responsible for placing and removing the signs according to city laws in the city of the Entry location. Each Entry will receive two flags and three numerical signs to be placed.
- 8. If either Applicant or the homeowner wishes to withdraw the Entry from the Tour, Applicant understands that Applicant will not receive a refund after July 24, 2017, but will receive a \$50 credit to be applied to an Entry in the next year's Tour, if any, if cancelled by August 1, 2017. After August 1, 2017, no credit will be given to the Applicant. Flags will not be given to an Applicant for an Entry not available for show. The HBA of F-M will provide the Applicant with one sign for the Entry reading "Not Available for Show."
- 9. Reported violations of the Rules and Regulations will be reviewed by the Remodelers Council ("Council") and may result in a suspension from participation in the next Tour, if recommended to the HBA of F-M Board of Directors and approved.
- 10. HBA of F-M may take exterior and interior photos of the Entry during Tour hours and Applicant allows their use for marketing purposes.
- 11. HBA of F-M may receive monies in conjunction with the Tour, including, but not limited to, the monies received from the Tour magazine and advertising. HBA of F-M has the sole right, title and interest to the proceeds. The Applicant will not receive and does not have claim to any of the proceeds. Further, the Applicant will not receive any financial consideration with respect to photographs or video taken pursuant to this agreement.
- 12. Applicant must maintain liability insurance on the Entry and the property where the Entry is located during the Tour and provide proof of this insurance to the HBA of F-M.
- 13. Applicant must have ownership and copyrights, if applicable, to all photos, logos and other images provided to the HBA of F-M.

- 14. The HBA of F-M has authority to close, postpone or reschedule the Tour. The HBA of F-M will notify the local media if the Tour closes, is postponed or rescheduled. Applicant will watch local media and/or www.hbafm.com for reported closures, postponement or rescheduling. If the HBA of F-M closes, postpones or reschedules the Tour due to inclement weather or otherwise, Applicant cannot open the Entry to the public and no refunds will be given.
- 15. Applicant must get pre-approval for promotions it intends to offer relating to a Tour Entry.
- 16. Rules and Regulations are subject to change at any time.
